



#### Motivation

- 802.3 AND 802.11 are important to home customers
- Many home AV networks will require both wired and wireless hops
- Time sync must be end-toend
- Considering wireless now will improve probability of end-toend interoperability





# Wireless time sync challenges

- Link delay changes over time
  - Multipath delay spread
    - Is statistically zero mean
  - Changes in link distance (mobility)
    - This effect is negligible
      - $\rightarrow$  100ns in 100 ms  $\rightarrow$  682 MPH (MACH 0.9)
- Wireless data rate is lower than Ethernet
  - Must ensure small time sync overhead
    - Wireless clocks have 5x better PPM (20PPM vs. 100PPM)
      - » Sync interval can be longer
- Link errors in .11 are very likely (10% drop rate)
  - Retransmissions result
- Effective data rate changes
  - Should only impact bandwidth not delay of 1st octet


### Time sync with IEEE 1588 Version 1

Goal: Synchronize clocks of networked nodes

- 1. Master schedules M1 for Tx
- 2. As it passes from MAC to PHY, t1 captured
  - Using master clock
- 3. Time t2 captured as passes from PHY to MAC
  - Using slave clock
- 4. M2 carries t1 to slave
- 5. Slave schedules M3 for Tx
- 6. t3, t4 captured as above
- 7. M4 carries t4 to slave

If link delay is fixed & symmetric:

Clock offset between master and slave = [(t2-t1) - (t4-t3)]/2



Will work ONLY if link delay is Fixed & Symmetric

# 1588 Version 2 adds Peer-to-Peer (P2P) Transparent Clocks (TCs)

Link delay is measured periodically (next page)

Asynchronously, Sync/Followup messages are multicast, link delay + residence time are accumulated per hop





Figure 8. Sync and Follow\_Up sent with Sync held at P2P TC until corresponding Follow\_Up arrives.

Follow\_Up processing time and sync interval are of the same order. Sync processing time is much less than Follow Up processing time.


#### PDelay measurement for P2P TC

(candidate method for AV at IEEE802.3 links)

Goal: measure peer to peer delay (could be replaced by e.g. PHY method)



- 2. Residential time in Responder T3 T2
- 3. PDelay shall be operated peer to peer
- 4. PDelay measurement is independent of sync messages



#### Location estimation with 802.11v

Goal: Measure distance between 802.11 entities in ns


- Requester schedules M1 for Tx
- 2. As it passes through the PHY, t1 captured
  - Using requester clock
- 3. Time t2 captured in PHY on Rx
  - Using slave clock
- 4. Responder MAC automatically sends M1 ACK very quickly (a control frame)
- 5. t3, t4 captured as above
- 6. M2 carries (t3-t2) to requester

If link delay is fixed & symmetric:

Link delay = 
$$[(t4-t1) - (t3-t2)]/2$$

Clock offset between master and slave = [(t2-t1) - (t4-t3)]/2

BUT Requester doesn't know t3 and t2!



Will work ONLY if link delay is Fixed & Symmetric


#### We need to consider these separately:


- 1. Protocol
- 2. Measurement (frame timestamp)

#### 1. Protocol differences

P2P TC Delay measurement

IEEE802.11 Task Group V





Differences (compared to IEEE 1588 PDelay):

- Data frame and MAC-generated control frame (an ACK) are used, not two data frames – IMPORTANT for Location accuracy
- (t3-t2) is sent, not both t3 and t2

Missing in 802.11v (compared to IEEE 1588 P2P TC)


Sync message not detected/time-stamped

#### 2. Measurement Differences

- AV time sync requires 100s of ns of accuracy
  - Measurement probably taken between MAC and PHY
- 802.11v doesn't define the precise timestamp point in the frame
  - Important for timestamp of SYNC messages
- Location estimation requires 1s of ns of accuracy
  - Measurement probably taken in the PHY

NOTE: Both measurements require an extension to the respective MAC service interfaces

# Putting it all together




- Define extension to MAC Service Interface to get timestamp information
  - Define measurement accuracy options, as appropriate for application
- 802.11v modifications:
  - Provide option to send information to responder additionally
  - Define timestamp capture point in frame


# Summary

- Residential AV users will benefit from synchronized playback over wired & wireless
- Time Sync interoperability is needed across 802 LANs
- 802.11 TGV approach is very similar to current p802.1as proposal to use IEEE 1588 version 2 PDelay
- Separated interoperability features from actual protocol and delay measurement method allows flexibility per media type.
- Next steps:
  - Specify service interface for packet timestamp
  - Recommend 802.11 TGV changes
  - Give .11 a "hook" in IEEE1588 (informative Annex)
  - Ensure maximum interoperability between .3 and .11 networks






Figure 11—Portion of the ISO/IEC basic reference model covered in this standard

11.6 Higher layer timer synchronization

11.6.1 Introduction

Higher layer timer synchronization is beyond the scope of this amendment. However, explanation on how the constructs in this amendment can be used to support such capabilities may be useful to the designer. One way to accomplish synchronization across a BSS is by multicasting synchronization (Sync) packets from the higher layers containing a time stamp and a sequence number. These packets would be opaque to the MAC and would be transported in the same way as any other MSDU (most likely addressed to the multicast address). Sync packets would be treated as a type of management packet by the higher layers. The time stamp in the Sync packet would contain the higher layer clock value at the time when the previous Sync packet was transmitted. The sequence number parameter has a value equal to the sequence number of the MSDU in which the time stamp is provided. The reason the packet would contain the time stamp for the previous Sync packet (rather than the current packet) is that hardware and layering constraints would prohibit the ability to provide a time stamp for the exact instant the current packet is transmitted within that packet. However, a MLME-HL-SYNC indication primitive allows the transmitting QSTA to know exactly when each Sync packet is transmitted. A receiving QSTA can similarly note the time when each Sync packet is received as well as the sequence number for that frame. The receiving QSTA would save this receive time indication for each packet along with its sequence number and compare the indication of the previously received Sync packet to the time stamp in the most currently received packet. This comparison allows the STA to compute an offset, which can be used to adjust its time reference to

match that of the synchronization source. The sequence number would ensure that the correct packet is being used for time stamp comparison. It is possible a packet is lost; in this case, the received time stamp for the lost packet should

The last symbol of the Sync frame is indicated by the PHY using the PHY-TXEND.confirm and PHYRXEND. indication primitives in the transmitter and receiver of the Sync frame, respectively. Practical limits on the coincidence of this indication and the last symbol of the Sync frame are implementation dependent. The accuracy of this technique also depends on the propagation delay between the source and receiving channel. However, both the time difference (between the PHY indication and the last symbol of the Sync frame) and the propagation delay can be considered as fixed-delay components. Therefore, they contribute only to the fixed time difference between the transmitter and receiver STAs' clocks and do not contribute to jitter. An implementation-dependent scheme can be used to cancel or minimize this fixed time difference. The Sync frame may also be relayed through the AP. In this case, the non-AP QSTA that generates the time stamps notes the reception of the multicast Sync frame from the AP as the indication to save the higher clock value for the next Sync frame. Receiving QSTAs would also similarly note the time when each Sync packet is received from the AP. The sequence number would include a value corresponding to the frame received from the AP. Other implementations (aside from what is described here) may also be supported.

# **Ethernet Timestamp Accuracy**

MAX RX+TX PHY processing delay :

100Mbps: 480ns1000Mbps: 328ns

- This gives maximum variation allowed by standard
  - Assumes Ons minimum
- We assume frame-to-frame variation in a specific PHY will be very small
  - Not true between PHYs from different vendors
