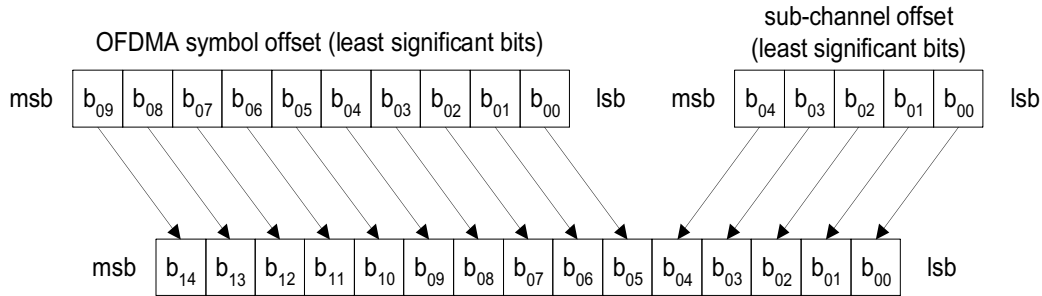


Figure 227 Creation of OFDMA Randomizer Initialization Vector

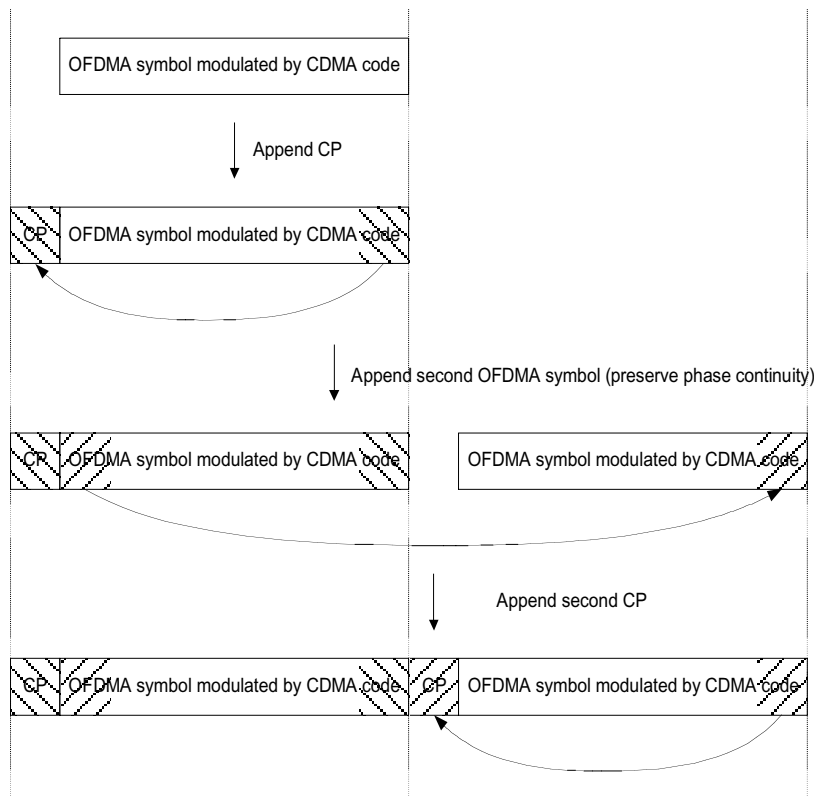


Figure 228 Initial-Ranging Transmission for OFDMA
