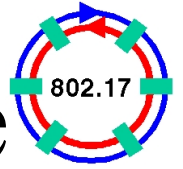
# Current Draft Status

- D2.1 authorized by P802.17 TF in January
  - This was a comment period and not a ballot
- Draft created by editors and posted February 15
  - Draft is now up to 603 pages
    - RPR  $\Rightarrow$  **R**ather **P**ortly **R**eference ☺
  - Comment period from February 15 to March 3
    - 15-day comment period
  - Comments posted on March 5
- 34 commenters sent in 1008 comments

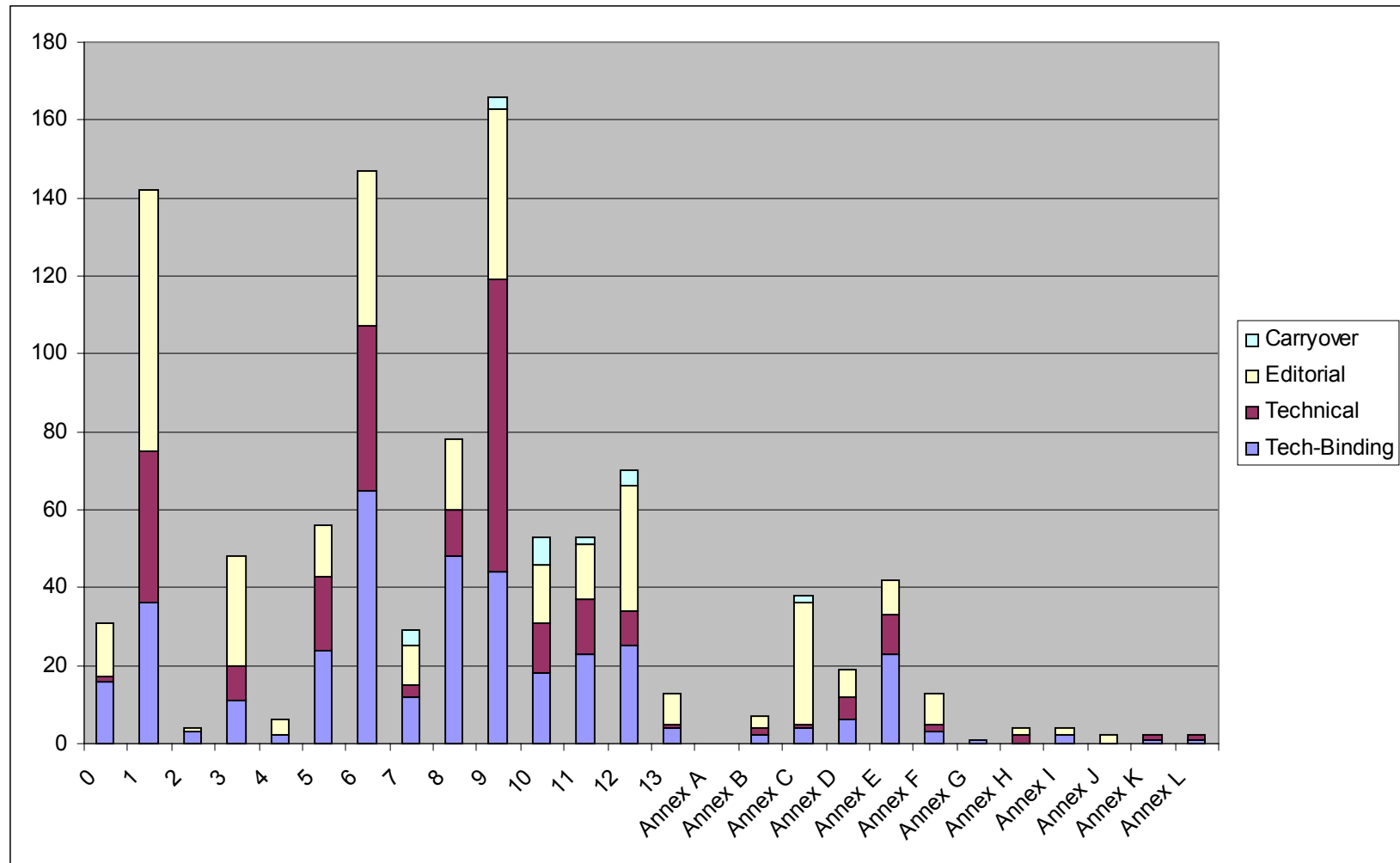


# Status of Comments on D2.1

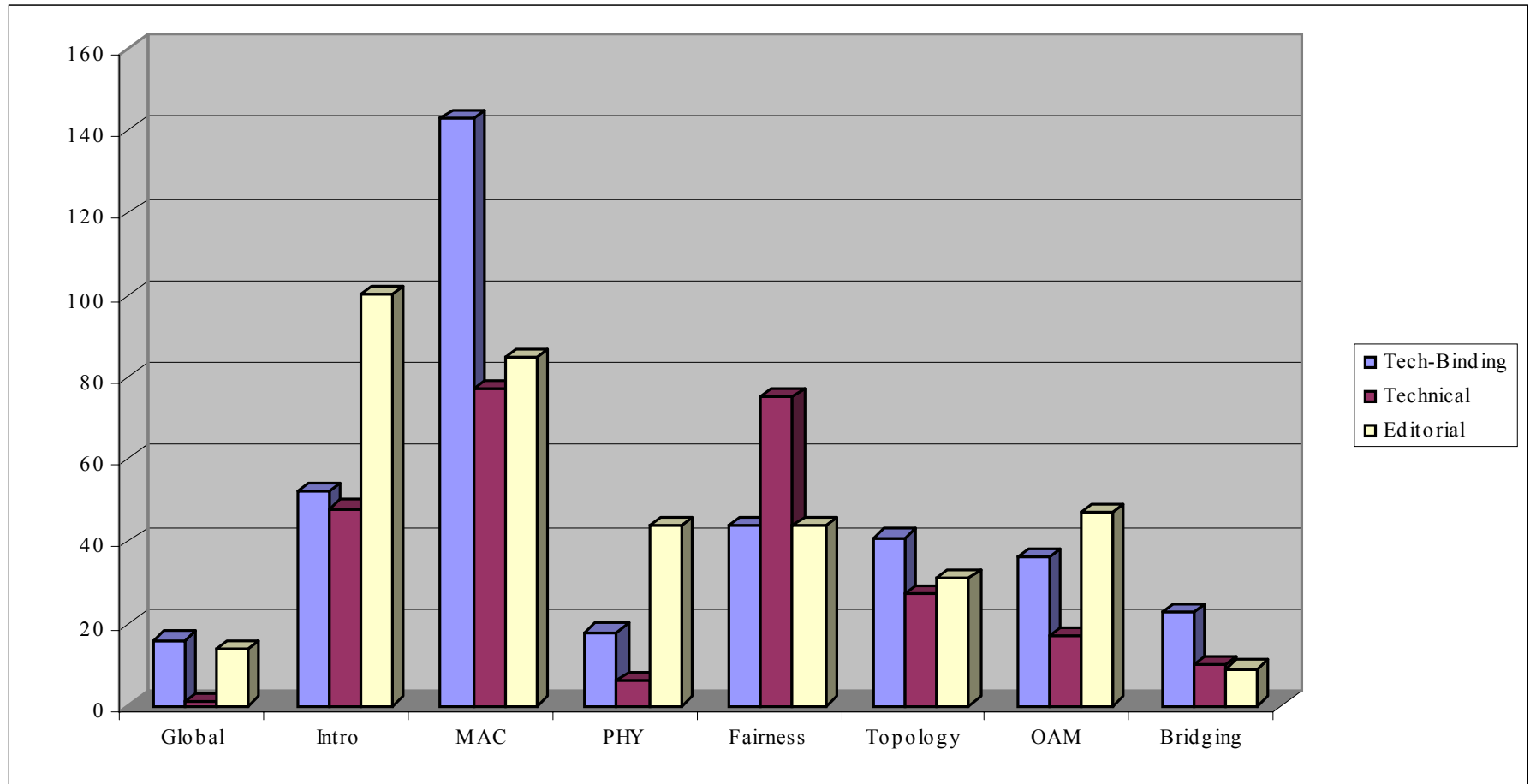
- 1008 valid comments received + 22 carryovers
  - 262 new Technical, 374 new Technical-Binding
    - The number of Tech-Binding now exceeds Technical!
  - 34 commenters (and one who sent in an approve ballot)
    - David James wins the cheap wine award with 270
- MAC section received maximum comments
  - 305 comments
- 2+ days to resolve all comments
  - Comment resolution will run morning, evening, night
  - Closing session Thursday will probably run late into night

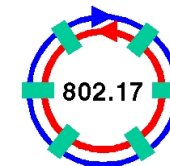


# Comment Distribution By Clause



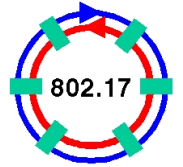
# Distribution By Section

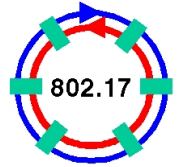

# Goals For This Meeting

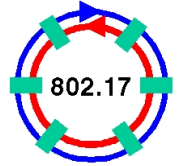
- Resolve comments on D2.1 to produce D2.2
  - 1030 comments – we have our work cut out for us
- Produce instructions for generating the next draft
  - Generate instructions to editors by resolving comments and adopting text from proposals
- Authorize creation of D2.2 draft based on instructions
  - D2.2
- Authorize D2.2 to be sent out for WG ballot





# Plan For Rest of Week

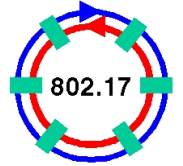
- Editorial schedule:
  - Monday morning: comment resolution (MAC and Fairness)
    - Attempt to make some early progress by resolving less critical comments
  - Monday evening: global comment resolution (Clause 0)
    - Resolve what we can (some will be sent to the WG)
  - Tuesday: comment resolution
    - Editors to collect global issues and hot-ticket items for discussion and possible resolution during mid-week meeting
  - Wednesday morning: mid-week meeting
    - Discuss global issues, resolve punted comments needed for further progress
    - Provide direction to groups for remainder of comment resolution
  - Wednesday afternoon, evening: more comment resolution
  - Thursday: Editors' reports, punted comments, Motion Madness

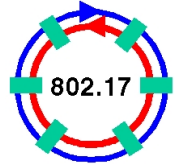

# Posting of CRDs and Reports

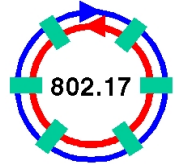
- CRDs will be posted by editors on the file server
  - Posting will be done as soon as possible after comment resolution session ends (and editors have had a chance to clean up CRD)
  - Posting will also be done on a nightly basis if comment resolution session spans 2 or more days
  - To retrieve the CRDs, look in the directory “latest\_CRD”
  - File names will be of the form “*section\_CRD\_date\_time*.USR” or “*clause\_CRD\_date\_time*.USR” where *section/clause*, *date* and *time* will be filled in by the editors
    - For example: MAC\_CRD\_1-14-03\_9PM.USR
- Editors reports will also be posted when done
  - To retrieve, look in the directory “editor\_reports”
  - File names will be “*section\_report.ppt*” or “*section\_report.pdf*”

Posted files will be kept up to date on a best-efforts basis!



# A Comment about Comments

- The disposition of each comment is determined at this meeting
  - A comment may be accepted (or accepted-modified) – closed
  - A comment may be rejected – closed, but see below
  - A comment may be unresolved – open
- Closed comments are not carried forward
  - Rejected technical comments (later, limited to technically binding) will be circulated with the new draft for review
    - This is done to see if anyone will change their vote on the basis of the rejection of that technically binding comment (in this case, they submit their own technically binding comments)
    - The rejected comment is still considered closed, however, and will not appear in the new database
- Unresolved comments are carried forward
  - Either the committee could not agree on a resolution, or the committee did not get enough time to consider the comments
  - Either way, these are the only D2.0 comments that will appear in the D2.1 comment database



# General Recommendations

- Stay focused
  - Technical editors will be moderating and limiting debate in the interests of progress
- Identify unresolved or contentious issues quickly
  - Deal with the difficult ones first; once they are out of the way, the minor issues will go faster
  - Try to avoid spending lots of time on the same comment twice – once in the CRG, and once in the WG
  - If an issue does not look like it can be laid to rest in the CRG, move it immediately to one of the WG sessions
- Look for duplicates
  - A lot of problems in the draft have been commented on by more than one person; group these and deal with them as a unit
