

Meeting Minutes SCC18 Adhoc
May 16, 2018
1PM ET

13:03 Meeting called to order.

Adhoc Chair reviewed agenda slides, covered the IEEE patent policy and participation rules.

13:04 Chair informs the group that minutes for the previous meeting are posted, asked if anyone that wanted to review the minutes hadn't had the chance to review, and asked if there were any changes to be made to the minutes. None responded. Chair instructs the webmaster to change the status of the 3/28 and 4/18/18 minutes to approved.

13:05 Moving to the main agenda, preparation for actions at the IEEE meeting in May.

1. PT716: 802.3 will need to delegate the SCC18 adhoc to submit comments for the as yet unpublished draft. Meeting is scheduled for July 2 in London that will be attended by our Category D Liaison. But that date should move because there's a 2-month requirement for ballot review.
2. ~~NFPA/SCC18: Need to request an alternate deadline for SCC18 proposals for PIs as the FR publish date is after the SCC18 60-day due date. The request would be to move this date to Aug 1. But at a minimum it needs to be July 13 so that it falls one day after the closing Plenary meeting in San Diego. If the deadline remains 60 days in advance, we need to request to delegate to the adhoc at the May meeting.~~ UPDATE: Because of the due date, there will not be any Public Comments submitted by SCC18 on behalf of IEEE. It is acceptable for individual committees to submit Public Comments with appropriate identification and disclaimer language in "5.1.3 'Statements to external bodies' of the IEEE-SA Standards Board Operations Manual".
3. Charter the SCC18 adhoc to respond on behalf of 802.3 in relation to the (nominal vs rated PIs) that will be discussed in the NEC TG on the topic, to expire July 13th.

13:17 Discussed the CC appointed nominal vs rated current TG. Chad to announce to the WG during his SCC18 closing report.

13:25 It was suggested that we submit positive PCs on the PIs we really appreciate.

13:29 Chad to email Christel about supporting the rejection of PI8757 with and IEEE PC.
