The group discussed the results of the Insertion Straw Poll. Despite the majority in favour of Option 4, Ali Ghiasi is still concerned about the effects of the IL equation changes on P802.3cd cables. Rich Mellitz agreed to run COM with the IL changes to assess the effect on cables, and provide results at the next Ad Hoc.

The group then discussed the other 4 highlighted comments. It was noted that the r01-41 has an equivalent comment against P802.3cd which will need to be resolved before P802.3bs comment resolution begins.

Andre discussed comment r01-24 with Adee Ran (commenter) and determined that this comment is truly editorial after all.

The group discussed r01-44 and determined that FOM_ILD already exists in Clause 92.11.3.1, although with a value of 0.13dB. It was agreed that we should give Compliance

board manufacturers time to determine whether reducing the value of this parameter to 0.1dB is acceptable.
