Maintenance Request #1259

This maintenance request was discussed. There was no objection to changing the status of this Maintenance Request to “Ready for Ballot”.

Maintenance Request #1260

Maintenance Request #1261

This maintenance request was discussed. IEEE-SA editorial staff confirmed that this error can be corrected during the IEEE P802.3bj publication preparation process. The status of this Maintenance Request will remain “Received” until publication.

Mr. Healey also brought to the group’s attention an error in Table 45-15a (register “1.20.15:12” indicated in the first body row and first column of the table should be “1.16.15:12”). IEEE-SA editorial staff confirmed that this error can also be corrected during the IEEE Std 802.3bj-2014 publication preparation process.

Mr. Healey forwarded both of these proposed changes to IEEE-SA editorial staff to be handled during the IEEE Std 802.3bj-2014 publication preparation process.

IEEE 802.3 revision plan proposal

Mr. Healey reviewed a proposed IEEE 802.3 Revision plan developed from project schedules submitted by Task Force Chairs. The plan includes initial Working Group ballot in November 2014, initial Sponsor Ballot in March 2015, and SASB approval in October 2015. No amendment Sponsor Ballots should circulate while the Revision document is circulating for Sponsor Ballot.

Mr. Healey reviewed the proposed IEEE 802.3 Revision PAR supporting this plan and implemented revisions to the PAR as agreed to by the group.
