#### 4. Review of Membership/Attendance

#### 5. Specific Items Related to Standard 765

Additional discussion of the relaxation of frequency requirements shows there needs to be further review for potential impacts to the standard. Additional review of published transmission requirements (NERC Stds. NUC-001 and PRC-024) will be required in order to determine if changes are required. This topic will be reviewed in greater detail during the next working group meeting in 17-01.

#### 6. Specific Items Related to Standard 1792

1792 ballot status was presented. Ballot responses resulted in a 93% approval rate. The ballot committee (Jason Bellamy and Mark Bowman) presented the ballot responses. It was motioned to re-ballot 1792 using the ballot committee responses and with the three minor editorial changes to 1792.

Motion to re-ballot 1792: Tim Lensmire

A vote was held for re-balloting 1792; 15 yays, 1 abstain and 0 nays.

As with Standard 765, Standard 1792 will have further evaluation for changes associated with relaxing the frequency requirements.
