9. Technical Paper Review

John McDaniel asked that the Renewable Energy Integration Subcommittee begin accepting transactions papers that fall into their scope for review. Currently these papers are being reviewed by the Distribution Subcommittee. Satish Ranade agreed to serve as editor until a permanent editor is found.

10. Subcommittee Reports

Tom asked for each subcommittee to provide a brief report of their activities at the General Meeting.

Capacitor Subcommittee:

Mark McVey reported that the committee and three working groups met on Wednesday, June 27, 2007. The Harmonic Filter Working Group (Std. 1531-2003) is in the process of re-affirming the standard. A revision will be considered if many negative ballots are received. The merger of NEMA1 and IEEE18 was discussed. Revisions to re-ballot Std. 1036, Guide for the Application of Shunt Capacitors is in progress.

Distribution Subcommittee:

Cheri Warren reported that a new project (P1569) was being created to address voltages at public and private facilities. She said that the subcommittee was proposing panel sessions, a working group paper, and a tutorial for the 2008 General Meeting. She pointed out that the subcommittee is using web-based meetings twice per year to improve their communications and ability to complete standards-related work.

ESMOL:

David Mitchell has retired and Thomas Buonincontri is serving as Chair of the ESMOL Subcommittee. The ESMOL Conference held October 15-19, 2006 in Albuquerque, NM was a success. The committee is working on Std. 516, Live Line guide. The committee is sponsoring a panel/roundtable on grounding.

General Systems:

Reza Iravani reported that four working groups and four task forces met at the General Meeting. He said that they are planning several panel sessions for the 2008 and 2009 General Meetings and that they are also working on two special publications.

Integration of Renewable Energy into the Transmission and Distribution Grids:

Satish Ranade reported that a small group met at the Orlando Joint Technical Meeting. The first formal meeting was held at the 2007 General Meeting on Wednesday, June 27, 2007. At the request of the Wind Power Coordinating Committee, the first working group "Wind Plant Collector System Design" was approved unanimously. The WG is co-sponsored by the Energy Development and Power Generation Committee. The WG will serve as a focal point within the Power Engineering Society (PES) for addressing issues related to the design of collector systems for wind plants.

The creation of a second working group "Wind Integration into T&D" was recommended. Surya Santoso, UT Austin is looking into forming this WG.

Lightning and Insulator Subcommittee:

The L&I Subcommittee is reorganized into two working groups. Each held a 'combo' session at the 2007 General Meeting. Comments on the revision to IEEE Std. 1410-1977 are being resolved.

Power Quality Subcommittee:

No report

TP&C Subcommittee:

Glenn Davidson reported that the subcommittee had a full schedule of working group and task force meetings and that the minutes and related presentations would be posted on the TP&C Subcommittee website. They have a joint WG with ESMOL on corrosion. They have agreed to enter a Technical Interchange Agreement (TIA) for the 2007 NESC.

DC and FACTS Subcommittee:

Ben Mehraban reported all of the working groups had met at the General Meeting. Their website has been linked to the T&D Committee website. Brian Johnson may move the website to the IEEE server. The Facts Control WG has finished its work. They are planning a panel for the 2008 General Meeting. The WG on Facts Education has compiled a list of major HVDC projects world wide.

12. Standards

Karl Mortensen discussed changes in the Standards Processes and to the Web-based systems.
