The finances of the Committee are in sound condition. As of February 1st (end of this reporting period), the balance in our account was \$120,083.56.

FYI: January 31st was essentially a "snap-shot in time" <u>after</u> all income & expenses were resolved from the previous Fall 2020 virtual meeting and <u>before</u> we started spending significant funds for the Spring 2021 Virtual Meeting.

Report period highlights include,

- The 2019 Audit was completed with satisfactory results,
- a 2020 Audit will not be required because we do not meet the minimum revenue / expense threshold,
- the Fall 2019 Meeting reported a profit because of lower expenses associated with virtual meetings,
- IEEE is scheduled to change our banking system software on May 1, 2021, which may have functionality to switch from cash-based accounting to accrual-based accounting system, and
- the Treasurer Officer position will be turned over to Troy Tanaka, Burns and McDonnell on July 1, 2021.
