Changed the sentence to "The proposed resource allocation methods are similar in principle to those of the Stream Reservation Protocol (SRP) specified in IEEE Std 802.1Q."

Replaced MSRP with SRP throughout the document.

802.3 comments on the CSD and their resolution

Comment:

1.2.3 Clarification requested. The distinct identity response says in the first paragraph that no existing standard provides dynamic resource allocation. Then the second paragraph says that the project replaces an existing standard. We interpret it to mean that the current standard does not provide dynamic resource allocation and the new one (that replaces an existing draft standard) will add this capability through replacement. Is this correct? What is the status of the IEEE P802.1Qdd project that this PAR proposed to replace?

• Response:

The reason for this replacement is that consensus has been reached in the 802.1 Working Group to specify the Resource Allocation Protocol as a standalone standard instead of an amendment to IEEE Std 802.1Q. Therefore, the P802.1Qdd PAR is proposed to be withdrawn and replaced by the P802.1DD PAR.

Removed "or approved project" from the first sentence in 1.2.3 to avoid confusion.
