# **EVENT REGISTRATION FEES & DEADLINES**

## Early: Before 6pm Pacific Time, December 6, 2013

- \$US 600 for attendees staying at the Hyatt Regency Century Plaza
- \$US 900 for all others (including local attendees not staying at the group hotel)

**Session Registration:** Registration is available through a secure website and requires a valid credit card for the payment of the registration fee; checks are NOT accepted for registration.

Any individual who attends any part of a meeting that is a scheduled part of an 802 Wireless Interim Session must register for the full session.

Session registrations are not transferable to another individual or to another interim session.

If you register for an IEEE 802 Wireless Interim Session and then are unable to attend, you must request cancellation of your registration before the cancellation deadline to be eligible for a refund of all or part of the fees paid.

# **USA VISA Invitation Letter**

The IEEE Standards Association can provide a letter inviting individuals to attend the session. You must register and pay for the upcoming plenary session in order to obtain an Invitation Letter.

Once your registration has been approved you may at any time select the link to "Generate a Visa Letter" from the VISA Information header on the event portal navigation bar. You will be asked to log in using the same UserID and Password that you used to register.

If you completed registration successfully, you will then be asked to provide some additional information.

- Your Date of Birth
- Your Place of Birth
- The Nationality of Your Passport (i.e. the issuing country)
- The Passport Number
- The Passport Expiration Date

Once this information has been accepted your personalized letter will be generated in PDF format and displayed on the screen for printing and saving. A copy of the visa letter will be sent as an attachment in an email to your email address. These letters have the IEEE Logo at the top, are properly signed by the IEEE-SA President, and should be printable on any common personal computer printer.

## Los Angeles International Airport (LAX) Transportation

#### **To/From Los Angeles International Airport**

**Super Shuttle -** offers 24-hour Los Angeles International Airport (LAX) service, 7 days a week, to and from Hyatt Regency Century Plaza.

Arriving guests will find a Shared Ride island outside of each baggage claim area. Look for blue vans with yellow lettering marked "Super Shuttle."

Departing guests make reservations 24 hours in advance of leaving Hyatt Regency Century Plaza for LAX. Phone: 800-258-3826 (outside California) or 310-782-6600 (inside California) or ask the hotel concierge.

Cost: \$US 14.00 each way

**Taxis** - can be found curbside on the Lower/Arrival Level islands at LAX in front of each terminal under the yellow sign indicating Taxis.

Passengers will be presented with a ticket stating typical fares to major destinations.

Only authorized taxis with an official seal issued by City of Los Angeles

Department of Transportation on each vehicle are permitted in the airport. It is illegal for any transportation services to solicit fares, and travelers using such services do so at their own risk.

Departing guests should speak with the hotel concierge to arrange transportation back to LAX.

Cost: approximately \$US 35.00 each way
