Letter Ballot #17

- The question: *“To forward to the IEEE 802 LMSC Executive Committee, for IEEE-SA Sponsor Ballot, P802.16-2004/Cor1/D1”*
- Results of LB:
 - Approve: 127
 - Disapprove: 24
 - Approval ratio: 85 %
 - Return ratio: 71%
- Comments received IEEE 802.16-05/015
 - 46 commentators
 - 304 comments (6 late)
 - 73 technically binding
 - 162 technically non-binding
 - 69 editorial
