- A Certificate of COVID-19 Vaccination

Unvaccinated/not fully vaccinated travelers who have proof of a negative result from an RT-PCR test or professional Antigen Test Kit within 72 hours of travel will be allowed entry with a valid passport, or a border pass for arrivals via border checkpoints.

Unvaccinated/not fully vaccinated travelers without a negative test result within 72 hours of travel are required to follow the public health instructions and guidelines as deemed appropriate by the Health Control officer at the point of arrival. All expenses incurred will be the responsibility of the travelers.
