IEEE Std 802.3.1-2013REV/IEEE Std 802.3.2-2019REV Joint Task Force meeting convened at **08:00 AM (all times in MST)**, Wednesday, March 13, 2024 by Marek Hajduczenia, Task Force Chair.

Marek Hajduczenia reviewed the agenda in https://www.ieee802.org/3/2/a/public/202403/agenda_d1_and_d2_202403_r02.pdf. Mr. Hajduczenia asked if there were any modifications to the agenda, none responded.
