IEEE Std 802.3.2-2019REV Task Force meeting convened at **08:00 AM (all times in MST)**, Wednesday, March 21, 2024 by Marek Hajduczenia, Task Force Chair.

Marek Hajduczenia reviewed the agenda in https://www.ieee802.org/3/2/a/public/202403a/agenda_d2_202403a_r02.pdf.

Mr. Hajduczenia asked if there were any modifications to the agenda, none responded. Mr. Hajduczenia then asked if there was any objection to approving the agenda, none responded, and the agenda was considered Approved by unanimous consent at **08:03**.

Mr. Hajduczenia reviewed Task Force decorum and asked if anyone from the press was present, none responded.
