# Guidelines for IEEE-SA Meetings

- All IEEE-SA standards meetings shall be conducted in compliance with all applicable laws, including antitrust and competition laws.
  - Don't discuss the interpretation, validity, or essentiality of patents/patent claims.
  - Don't discuss specific license rates, terms, or conditions.
    - Relative costs of different technical approaches that include relative costs of patent licensing terms may be discussed in standards development meetings.
      - **Technical considerations remain the primary focus**
  - Don't discuss or engage in the fixing of product prices, allocation of customers, or division of sales markets.
  - Don't discuss the status or substance of ongoing or threatened litigation.
  - Don't be silent if inappropriate topics are discussed ... do formally object.

# Participation in IEEE 802 Meetings

**Participation in any IEEE 802 meeting (Sponsor, Sponsor subgroup, Working Group, Working Group subgroup, etc.) is on an individual basis**

- **Participants in the IEEE standards development individual process shall act based on their qualifications and experience. ([https://standards.ieee.org/develop/policies/bylaws/sb\\_bylaws.pdf](https://standards.ieee.org/develop/policies/bylaws/sb_bylaws.pdf) section 5.2.1)**
- **IEEE 802 Working Group membership is by individual; “Working Group members shall participate in the consensus process in a manner consistent with their professional expert opinion as individuals, and not as organizational representatives”. (subclause 4.2.1 “Establishment”, of the IEEE 802 LMSC Working Group Policies and Procedures)**
- **Participants have an obligation to act and vote as an individual and not under the direction of any other individual or group. A Participant’s obligation to act and vote as an individual applies in all cases, regardless of any external commitments, agreements, contracts, or orders.**
- **Participants shall not direct the actions or votes of any other member of an IEEE 802 Working Group or retaliate against any other member for their actions or votes within IEEE 802 Working Group meetings, see [https://standards.ieee.org/develop/policies/bylaws/sb\\_bylaws.pdf](https://standards.ieee.org/develop/policies/bylaws/sb_bylaws.pdf) section 5.2.1.3 and the IEEE 802 LMSC Working Group Policies and Procedures, subclause 3.4.1 “Chair”, list item x.**

**By participating in IEEE 802 meetings, you accept these requirements. If you do not agree to these policies then you shall not participate.**

# Maintenance request 1337

---

- Separate point-to-multipoint into its own standard within the IEEE 802.3 family, e.g., “IEEE Std 802.3.n Standard for Multiport Access Ethernet”
- In scope: Yes/No (?)
- Errata: ~~Yes~~/No
- Complete: ~~Yes~~/No
- The request does not propose specific revision text (“TBD”).
- Remains marked as “Received” until proposed text is provided and a more sufficiently clear IEEE 802.3 procedure to move forward is provided

# Maintenance request 1342

---

- IEEE Std 802.3cd-2018 adds new PMDs but did not allocate MDIO ability bits for them
  - 100GBASE-[S, C, K]R2, 100GBASE-DR, and 200GBASE-[S, C, K]R4
- Allocate the bits for these PMDs (proposed assignments are listed in the request)
- In scope: Yes/~~No~~
- Errata: ~~Yes~~/No
- Complete: Yes/~~No~~
- Change status to “Ready for ballot” and forward to P802.3cn for consideration

# Maintenance request 1343

---

- In 97.3.6, RX\_AGGREGATE, RX\_FRAME, and TX\_AGGREGATE are defined as messages but they are variables internal to the PCS
- Change all instances of RX\_AGGREGATE, RX\_FRAME, and TX\_AGGREGATE to rx\_aggregate, rx\_frame, and tx\_aggregate respectively
- Move definitions from 97.3.6.3 Messages to 97.3.6.2.2 Variables and modify them as stated in the request.
- In scope: Yes/~~No~~
- Errata: ~~Yes~~/No
- Complete: Yes/~~No~~
- Change status to “Ready for ballot”

# Maintenance request 1344

---

- Proposes to change 99.4.6 as follows
  - ... the Express filter ~~passes the RS PLS\_DATA.request~~issues ePLS\_DATA.indications to the eMAC ...
- The actual issue seems to be that “RS PLS\_DATA.request” should be “RS PLS\_DATA.indication”
- The proposed text loses the fact that ePLS\_DATA.indication convey values received via RS PLS\_DATA.indication
- In scope: Yes/~~No~~
- Errata: ~~Yes~~/No
- Complete: Yes/~~No~~
- Ask the submitter to consider updating the request to only change “RS PLS\_DATA.request” to “RS PLS\_DATA.indication”

# Maintenance request 1345

---

- Typos in 45.2.1.191.1
  - Incorrect register number: 1.2307.15:13 should be 1.2308.15:13
  - Bits 15:13 are “RO” and should be “R/W” (they are control bits)
- In scope: Yes/~~No~~
- Errata: ~~Yes~~/No
- Complete: Yes/~~No~~
- Change status to “Ready for ballot”

- It will be forwarded to P802.3cm for consideration
