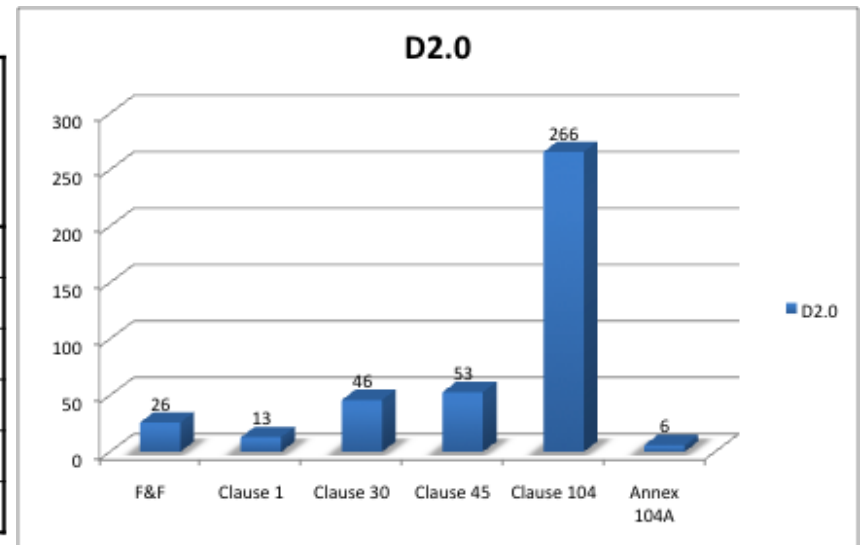

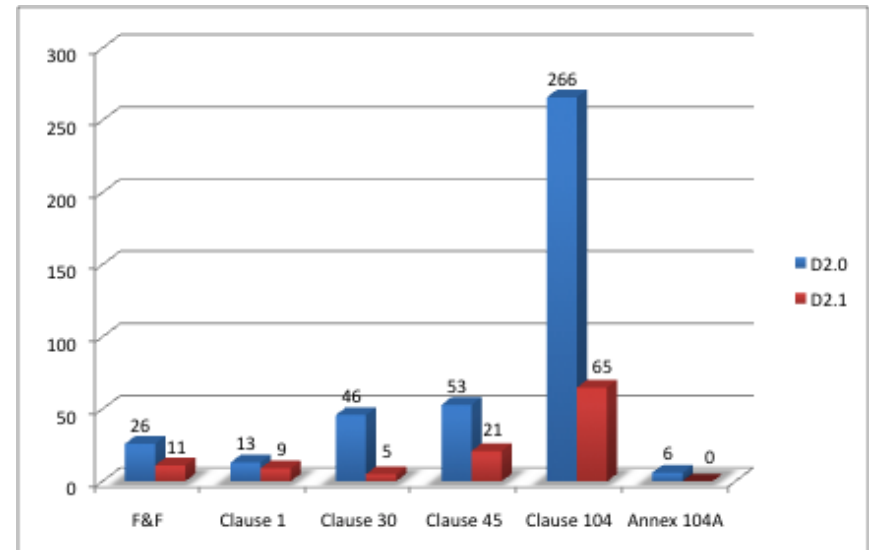


- Met during the January 2016 interim meeting
