**Abstract:** This Liaison Statement replies to the inquiry regarding the comments of IEEE 802.3 Ethernet WG on the proposed revision of Recommendation K.147 at Last Call (LC) of Alternative Approval Process (AAP).

ITU-T Study Group 5 would like to thank IEEE 802.3 Ethernet WG for the liaison IEEE 802.3 Ethernet WG-LS115.

ITU-T SG5 Question 2 (Q2/5) has reviewed the requests written in IEEE 802.3 Ethernet WG-LS115, and the comments from IEEE 802.3 Ethernet WG on K.147 at LC of AAP (also attached as “comments-802d3-SG5-TD561-R2.docx – the IEEE 802.3 WG comments in the ITU comment form” on the WG-LS115).

Based on the comments and discussions at the Q2/5 meeting in June 2023, including the comments from the IEEE 802.3 Ethernet WG representative, Q2/5 decided that, in order to make the title and scope consistent with the main body of the draft ITU-T K.147 at LC of AAP, the title and the scope of ITU-T K.147 will have to be changed.

Furthermore, all the comments on K.147 at LC have been discussed – and a consensus has been reached – within Q2/5, including the agreement from the IEEE 802.3 WG representative. The modifications based on the Q2/5 consensus have been applied to the draft revision of K.147 at LC for Additional Review (AR) of AAP, the draft of which is available at:
