IEEE Std 1860 co-sponsorship – It is proposed that the Transformers Committee will be a co-sponsor of this standard.

IEEE 693 amendment – It was discussed that this working group is moving ahead with a transformer model for seismic studies that will not be verified and there is evidence that it has known flaws with significant impact on accuracy. There is elevated concern with the direction of the working group and it was recommended that the Transformers Committee take some action. The Transformers Committee Chair will file an appeal with the responsible technical committee after the response from the 693 CRG meeting is received.

C57.153 Paralleling Guide PAR – There is a request from NESCOM to change the from Master/Follower to Leader/Follower to be compliant with the unapproved IEEE 3400 inclusivity standard. The Chair will respond to the Nescom comments.
