Celestial Seasonings - Waiver

I, _____, understand that I will be touring a working manufacturing facility, where hazardous materials, machinery, and processes present risk of serious injury or death. I understand that, on this tour, I may be exposed to raw ingredients, which may cause nausea, lightheadedness, serious allergic reactions, or other serious or deadly reactions.

In consideration of being allowed to participate in this tour, I agree to the following terms:

I understand I am solely responsible for my own safety and well-being during the tour and that I must obey all safety rules and regulations, including but not limited to wearing any personal protective equipment (PPE) provided to me, including a hair net.

I acknowledge I have been advised of the hazards associated with the tour, including but not limited to risks of falls, cuts, burns, electrocution, and exposure to hazardous chemicals, and that I have had an opportunity to ask questions and seek clarification regarding these hazards.

I agree to follow all instructions given to me by the tour guide or any other authorized personnel, including a Chaperone, and to immediately report any safety concerns or incidents to the tour guide or authorized personnel.

I understand I may not participate in this tour if I am intoxicated.

I understand I am prohibited from bringing any of the following items into the Celestial Seasonings Facility at any time: alcoholic beverages, illegal substances under state or federal law, weapons of any kind or objects that appear to be weapons.

I agree to indemnify and hold harmless the manufacturing facility, its employees, agents, and representatives from any and all claims, damages, losses, liabilities, costs, and expenses arising from my participation in the tour, including but not limited to personal injury, property damage, or wrongful death.

I understand if I do not follow these terms or abide by all other rules presented by Hain Celestial at the time of the tour, I will be required to leave the Hain Celestial property immediately.

I agree this waiver shall be governed by and construed in accordance with the laws of the State of Colorado and that any disputes arising out of or relating to this waiver, or the tour shall be governed by the State of Colorado.

Additional Factory Tour Information and Restrictions

Age Restrictions:

- Children under 5 are not permitted on the factory portion of the tour.
- Children under 15 must be accompanied by an adult on the factory portion of the tour.

Dress Code and Personal Items:

- Small clutches (max size 4.5" x 6.5") and outerwear (coats, vests, sweaters) are permitted in the factory. A limited number of lockers are available for personal item storage while on tour.
- Hairnets and beard nets (if applicable) must always be worn in the factory.

Animals:

- No animals, including service animals, are allowed on the factory portion of the tour.
- Food and Beverages:
- No outside food or beverages, including candy, gum, or glass containers, are allowed on the factory portion of the tour.

Photography:

- No photography or video recording is allowed during the tour.

Accessibility:

- Wheelchairs and walkers are welcome; courtesy wheelchairs are available on a first-come, first-served basis. Please note 30 minutes of the approximately 45-minute tour consists of walking or standing on concrete surfaces.

Prohibited Items:

- Alcohol and illegal substances under Federal law
- Weapons, including toy guns and swords.
- Remote-controlled devices, such as drones and electric skateboards
