At the Porto Meeting, the Committee was most proud and pleased to present the PES Transformers Committee Distinguished Service Award for 2008 to Dr. Ramsis S. Girgis. Ramsis was elected and IEEE Fellow in 1993, has been a long-time participant and member of the Committee, and has served as both a WG and SC leader. He is recognized in the industry for his knowledge and expertise in the study of transformer core performance and transformer noise. He has over 40 years of R&D experience in the areas of power, distribution, and high frequency transformers, and has published and presented over 60 scientific papers in IEEE, IEE, CIGRE, and other international journals. Ramsis has been a mentor to many young engineers and regularly participates in tutorial sessions for the Committee. The 2008 Transformers Committee Distinguished Service Award is presented to Ramsis Girgis for his exceptional service to the Committee and to our industry.

In addition to this technical activity, Greg has done pioneering work for the Committee in development of processes and procedures for meetings planning and arrangements, in the specification, refinement, and implementation of the Association Management System for Committee record keeping and communication, and in responsibly maintaining Committee financial records and developing processes to allow the Committee to meet the growing financial auditing requirements of the IEEE. Greg's work in planning, scheduling, and meeting arrangements results in cost effective, highly functional meetings that also emphasize the value of social camaraderie and ongoing education for all our participants.

6.7 IEEE 2008 Herman Halperin Award

At our previous meeting, the Committee recognized and applauded Bob Degeneff, recipient of the 2008 IEEE Herman Halperin Transmission and Distribution Award. Notation of that award did not make the prior Awards Report, and is included here. The award was presented at the PES General Meeting this past summer in Pittsburgh. Excerpting from the award citation: "Robert C. Degeneff is known in the power engineering field for his technical contributions of almost four decades to the modeling of transformer coils and windings. Dr. Degeneff's research has led to the development of industry standards in the computation of transient voltages within transformer windings, allowing for the efficient design of insulation structures, reducing power loss in a transformer. An IEEE Fellow, Dr. Degeneff holds eight patents, published seven dozen papers, and several chapters in books in the electric power area. In addition, he is a professional engineer in New York and a member of several professional societies including Eta Kappa Nu." The Committee again congratulates Bob for this award.

6.8 Nominations for IEEE, PES, and Technical Council Awards
